

## TERMS AND CONDITIONS OF REFER A SCHOOL

### Epson Refer a School Promotion

1. Any school (the “Referring School”) that refers another school (the “Referred School”) to purchase any new Epson products between **29.01.2024 until 31.12.24** (the “Qualifying Period”) in the Republic of Ireland can claim a discount on the following refurbished product bundles:

#### BUNDLE ONE

2. The level of discount that can be received by the Referring School is dependent on the value that the Referred School purchases as follows:

#### BUNDLE ONE

<b>Referred School purchase value</b>	<b>Referring School discount</b>
€500 - €2,500	€290
€2,501 – €5,000	€390
€5,001 +	€490

#### BUNDLE TWO

<b>Referred School purchase value</b>	<b>Referring School discount</b>
€1,000 - €5,000	€730
€5,001 – €10,000	€930
€10,000 +	€1,130

3. The Epson products must be purchased by the Referred School at full price during the Qualifying Period directly from an Epson authorised reseller.
4. Both the Referring School and the Referred School must be located in the Republic of Ireland.
5. Products purchased by the Referred School which will be resold to a third party are not eligible for this Promotion. Resellers may not submit claims on behalf of schools.
6. The Promotion is not open to Epson employees, agents, distributors, resellers, retail employees of participating stockists or anyone connected with the Promotion.
7. The Promotion is not available on any second hand, refurbished or reconditioned stock in the first instance that may be purchased by the Referred School.
8. The Referred School must complete their purchase before 31<sup>st</sup> December 2024
9. Claims by the Referring School for the refurbished bundles can be completed up to 31<sup>st</sup> March 2025.

### How to Claim

11. Once the Referring School has gained agreement with another school that the latter will purchase Epson products at full price, the Referring School must visit [www.epson.ie/referaschool](http://www.epson.ie/referaschool) and complete the registration form to demonstrate that they have referred another school.
12. Once the Referred School has bought from an Epson authorised reseller, the Referring School will be sent a link to the refurbished shop to claim a discount on a refurbished bundle.

### Restrictions

13. If the Epson product, which is initially purchased by the Referred School, is returned to the seller for any reason, the Referring School's entitlement to claim a discount on refurbished bundles is forfeited and any products already shipped to the Referring School must be returned to the Promoter within seven days.
14. The Promoter reserves the right to request additional evidence to help validate a claim if it believes that it may not be legitimate.
15. A claim will not succeed if:
  - a. the Epson products were not purchased within the Qualifying Period
  - b. the registration form was not completed in full
  - c. you have not complied with these terms and conditions
