

## **Terms & Conditions of the Epson 'ReadyPrint Flex Cashback Promotion'**

Instructions on how to participate form part of these Terms & Conditions. Participation into this '**ReadyPrint Flex Cashback Promotion**' (hereinafter the "**Promotion**") is deemed acceptance of these Terms & Conditions.

### **1. DEFINITIONS**

**"Promoter"** means: **Epson Europe B.V.** (referred to as Epson) having its registered office in Amsterdam, The Netherlands. For all correspondence, please write to the following address: Epson UK, 3rd Floor, The Clarendon Works, 37-39 Clarendon, Road, Watford WD17 1JA.

**"Promotion Period"** commences at 00:00 (CET, Central European Time) on **01.06.2025** and closes at 23:59 (CET) on **30.09.2025**.

**"Participant"** means: Any person aged 18 years and over residing in one of the Territories, as stated below, at the time of the Promotion. Participants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions.

Only end users who qualify as Participants are eligible; retailers are not permitted to submit claims on behalf of customers.

Employees of the Promoter, its parent company, subsidiaries, affiliates or other parties, who are in any way involved in the development, production, or distribution of this promotion, as well as the immediate family (spouse, parents, siblings, children) and household members of each such employee and/or authors, are not eligible to participate in this promotion.

**"Territory"** means: Ireland

### **2. PROMOTION DETAILS**

To be eligible for this Promotion, Participants must:

The Promotion applies to Selected Products purchased during the Qualifying Period directly from Epson or an Epson Authorised Reseller in the Territory.

Promotion is subject to a maximum of two (2) claims per household. Only one (1) claim may be made per Selected Product.

### 3. ACCEPTANCE OF TERMS AND CONDITIONS

Participation in this promotion implies acceptance of these terms and conditions. The Promoter reserves the right to refuse participation in the promotion at any time in respect of any participant who has not complied with these terms and conditions.

### 4. MECHANICS OF THIS PROMOTION

- i. The Participant purchases a Selected Product between **01.06.2025** and **30.09.2025**.
- ii. Within 30 days of purchasing a Selected Product the Participant submits their cashback claim online at [www.epson.ie/readyprintcashback](http://www.epson.ie/readyprintcashback), uploads a copy of their receipt and a photo of the serial number from their Selected Product
- iii. Once the claim has been received the Participant will automatically receive confirmation of receipt of the claim via e-mail from the Promoter.
- iv. The Participant must sign up for ReadyPrint Flex using the promo code **FLEXCB** at [www.epson.ie/readyprint](http://www.epson.ie/readyprint) by 30.11.2025.
- v. Once the Participant has registered for ReadyPrint Flex, the Participant will automatically receive confirmation email of registration.
- vi. Closing date for signing up for ReadyPrint Flex is 30.11.2025. Closing date for claims is 30.10.2025 (30 days after purchase date).

## 5. RESTRICTIONS

- I. Where the cash back payment constitutes a taxable benefit, the tax liability lies with the recipient.
- II. If the Selected Product which is the subject of a claim is returned to the seller for any reason the customer's entitlement to claim cashback is forfeited and any cashback paid to the customer must be repaid to the Promoter within seven (7) days.
- III. The Promoter reserves the right to request additional evidence to help validate a claim if it believes that it may not be legitimate.
- IV. A claim will not succeed if:
  - a. The Selected Product was not purchased within the Qualifying Period;
  - b. You have not subscribed to ReadyPrint Flex by 30.11.2025
  - c. The claim form was not completed in full;
  - d. The proof of purchase and a photo from the serial number of the device was not supplied or was illegible;
  - e. The claim was not submitted after thirty (30) calendar days from the date of registration of purchase;
  - f. You have not complied with these terms and conditions

## OTHER

6. Promoter will not accept responsibility for lost claims. Promoter will reject claims received after the closing date and those which it reasonably considers to be incomplete, illegible or fraudulent.
7. The cashback payment will be made by bank transfer after thirty (30) days of signing up to ReadyPrint Flex provided that the cashback claim has been submitted in full within the 30 days of purchase date. The Promoter will only make bank transfer to an account that is set up in the country where you made the purchase of the Epson product or a country under the SEPA (Single Euro Payments Area). The Promoter is not liable for any bank costs incurred relating to any bank transfers of the cash back payment. Accordingly, if your bank charges you, such charges will be deducted by your bank from the cash back amount.
8. The promotion is not available on any second-hand, refurbished, or reconditioned stock or in conjunction with any other promotions.
9. Proof of purchase must be a clear and legible copy of the retail receipt or invoice, displaying the retailer's name, date of purchase, product name, and purchase price
10. The contents of the cashback given are not transferable or exchangeable.

- 11.** If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Participant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
- 12.** Any cost associated with accessing the Promotion website is the Participant's responsibility and is dependent on the Internet service provider used.
- 13.** Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including but not limited to, where arising out the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoters control); (b) any theft, unauthorised access or third party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in value to that stated in these Terms and Conditions; or (e) any tax liability incurred by a Participant.

## **14. CHANGE OF TERMS**

The terms of the promotion are final and binding. Epson reserves the right to amend or cancel the terms of this promotion or to withdraw this promotion at any time without reason.

## **15. PERSONAL DATA**
