### 4. MECHANICS OF THIS PROMOTION

- 4.3. There the Participant will be asked to complete the claim form and submit it together with a copy of proof of purchase and a photo of the serial number from the product.

  They will be asked to provide their personal details, including bank details
- 4.4. Once the claim has been received, the Participant will automatically receive confirmation of receipt via email from the Promoter, with a second email within ten (10) working days of such date confirming acceptance or denial of the claim.
  - 4.5. The last date upon which you can submit a claim is on **30.10.2025**.

## 5. RESTRICTIONS

- 5.1. Where the cashback payment constitutes a taxable benefit, the tax liability lies with the recipient.
- 5.2. If the Selected Product which is the subject of a claim is returned to the seller for any reason the Participant's entitlement to claim cashback is forfeited and any cashback paid to the Participant's must be repaid to the Promoter within seven (7) days.

- 5.5. Only end users who qualify as Participants are eligible; retailers are not permitted to submit claims on behalf of customers.
- 5.6. Employees of the Promoter, its parent company, subsidiaries, affiliates or other parties, who are in any way involved in the development, production, or distribution of this promotion, as well as the immediate family (spouse, parents, siblings, children) and household members of each such employee and/or authors, are not eligible to participate in this promotion.

#### 6. General

- 6.1. Promoter will not accept responsibility for lost claims. Promoter will reject claims received after the closing date and those which it reasonably considers to be incomplete, illegible or fraudulent.
