Epson Print Admin (EPA) is a server-based solution that creates a secure printing, scanning and copying environment through user-authentication with card readers, logins/passwords and PIN codes.

It also offers additional features such as 'scan and send to me' (email and folder), employee-education notifications and enhanced administrative tools that provide welcome boosts to productivity, environmental goals and efficiency.

The Advanced Workflows functions enable administrators to easily create scan profiles with document capture, processing and delivery to pre-defined destinations, including Cloud storage services. The automated capture enables the creation of Searchable PDF, PDF/A in 29 languages, job separation with barcodes, folder and documents naming with Zonal OCR, barcodes, skip blank pages, and much more.

Enhance productivity

Save time by personalising user interfaces to employee profiles. The 'scan and send to me' feature sends scanned documents to authenticated users at the touch of a button. Storing scans to pre-defined folders avoids misrouting and enhances user experience.

Administrate easily

EPA offers advanced print, copy, and scan functionality through one web interface. Simple to access and use, this helps you optimise your fleet quickly.

Integrate with ease

You can integrate EPA seamlessly into your IT infrastructure with the local user database or Directory Services such as Active Directory, Open LDAP, Microsoft Entra ID, Microsoft Entra DS, Google Cloud Directory, Google Secure LDAP.

Seamlessly capture documents to Cloud services

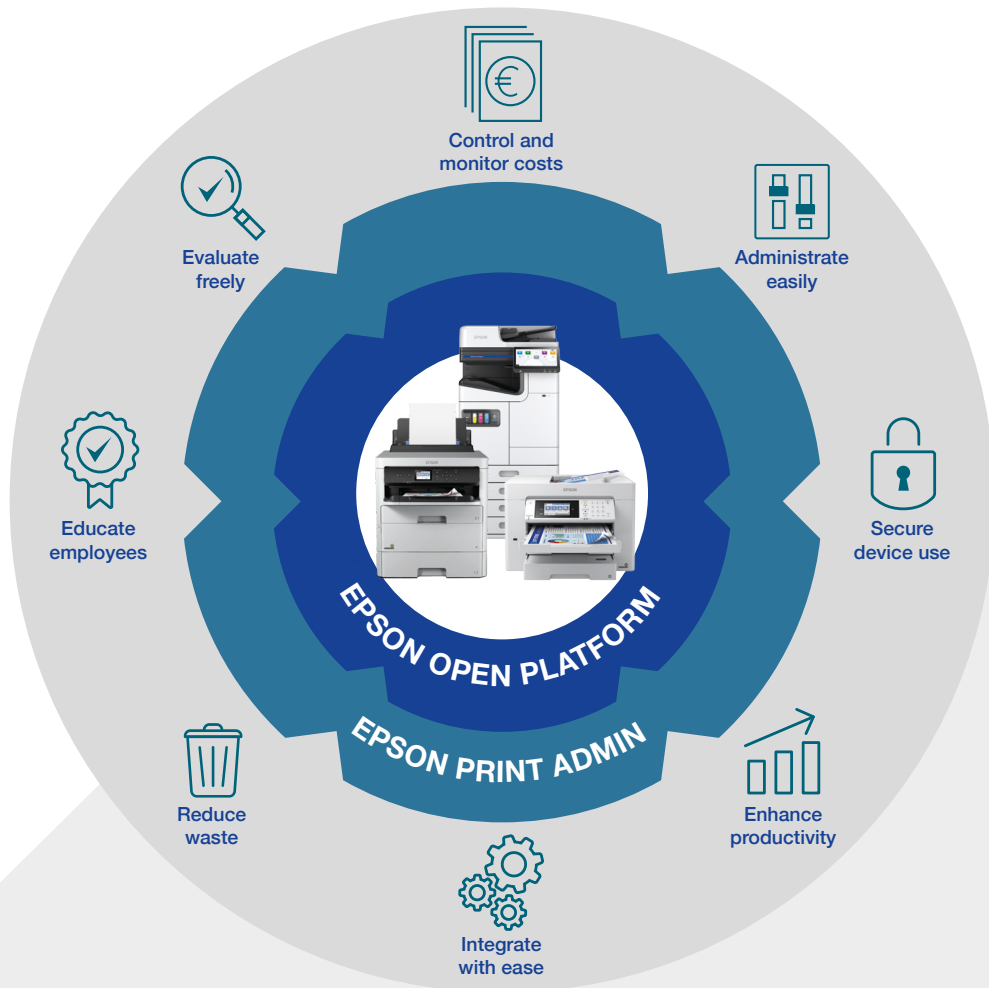
Scan documents directly to OneDrive for Business, SharePoint Online, Microsoft Teams and Google Drive.
