

## **Terms & Conditions of the Epson 'Lifestudio FREE Nespresso offer'**

Instructions on how to participate form part of these Terms & Conditions. Participation into this **'Lifestudio FREE Nespresso offer'** (hereinafter the **"Promotion"**) is deemed acceptance of these Terms & Conditions.

### **1. DEFINITIONS**

- 1.1. **"Offer"** means: the provision of a Nespresso Vertuo Pop Coffee Machine, which is gifted to the Participant under the Terms & Conditions of this Promotion. The Offer is subject to the Participant's compliance with all specified requirements and conditions as outlined in the Terms and Conditions hereunder;
- 1.2. **"Promoter"** means: **Epson Europe B.V.** (referred to as Epson) having its registered office at Hoogoorddreef 5, 1101BA, Amsterdam, The Netherlands. - 1.3. **"Promotion Period"** commences at 00:00 (GMT, Greenwich Mean Time) on 01.11.2025 and closes at 23:59 (GMT) on 28.02.2026;
- 1.4. **"Participant"**, and/or **"you"**, **"your"** means: Any person aged 18 years and over residing in one of the Territories, as stated below, at the time of the Promotion. Participants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions;
- 1.5. **"Territory"** means: United Kingdom

### **2. PROMOTION DETAILS**

To be eligible for this Promotion, Participants must:

- 2.1. Purchase a new Lifestudio projector from the list of eligible products shown in the table below (the "Selected Products") during the Promotion Period and submit your claim online.

- 2.2. The Promotion applies to Selected Products purchased during the Promotion Period directly from Epson or an Epson Authorised Reseller in the Territory, as listed at the website of the Promotion.
- 2.3. Promotion is subject to a maximum of two (2) claims per household. Only one (1) claim may be made per Selected Product.

### **3. ACCEPTANCE OF TERMS AND CONDITIONS**

Participation in this Promotion implies acceptance of these terms and conditions. The Promoter reserves the right to refuse participation in the Promotion at any time in respect of any participant who has not complied with these terms and conditions.

### **4. MECHANICS OF THIS PROMOTION**

- 4.1. The Participant purchases a Selected Product within the Promotion Period;
- 4.2. Within thirty (30) days of purchasing a Selected Product, the Participant needs to submit their claim online at [www.epson.co.uk/coffee](http://www.epson.co.uk/coffee), upload a copy of their receipt and a photo of the serial number from the device. The last date upon which the Participant can claim the Offer is thirtieth (30<sup>th</sup>) day after the day the Participant purchased the Selected Product.
- 4.3. Once the claim has been received, the Participant will automatically receive confirmation of receipt of the claim via email from the Promoter at the email address the Participant has entered during the online claim submission.
- 4.4. The Promoter will validate the claim within ten (10) business days from online submission of the claim and will send confirmation to the Participant as soon as possible, via email at the email address the Participant has entered during the online submission.
- 4.5. The Offer will be delivered to the address the Participant enters during the online claim submission, within the Territory, and will be dispatched within thirty (30) days from the claim validation.
- 4.6. Once the Offer has been shipped, you will receive an email from us with a Track & Trace code, which you can use to check the delivery status.

### **5. RESTRICTIONS**

- 5.1. The Promoter reserves the right to request additional evidence to help validate a claim if it believes that it may not be legitimate or if the evidence provided is insufficiently clear.
- 5.2. The availability of the Offer is strictly subject to current stock levels in the Territory. The Promotion may be terminated without prior notice if the stock is depleted. Participants

are advised that the offer is available on a first-come, first-served basis, and no guarantees can be made regarding the availability of the Offer once the stock has been exhausted.

5.3. A claim will not succeed if:

5.3.1. The Selected Product was not purchased within the Promotion Period;

5.3.2. The Selected Product was not purchased from Epson or an Epson Authorised Reseller listed on the Epson Authorised Resellers list found on the website of the Promotion;

5.3.3. The claim form was not completed in full;

5.3.4. The proof of purchase and a photo of the serial number from the device was not supplied or was illegible;

5.3.5. The claim was not submitted within thirty (30) calendar days from the date of purchase;

5.3.6. The Participant has not complied with these Terms and Conditions.

5.4. Only end users who qualify as Participants are eligible; retailers are not permitted to submit claims on behalf of customers.

5.5. Employees of the Promoter, its parent company, subsidiaries, affiliates or other parties, who are in any way involved in the development, production, or distribution of this Promotion, as well as the immediate family (spouse, parents, siblings, children) and household members of each such employee and/or authors, are not eligible to participate in this Promotion.

## 6. OTHER

6.1. Promoter will not accept responsibility for lost claims. Promoter will reject claims received after the closing date and those which it reasonably considers to be incomplete, illegible or fraudulent.

6.2. The Promotion is not available on any second-hand, refurbished, or reconditioned stock or in conjunction with any other promotions.

6.3. Proof of purchase must be a clear and legible copy of the retail receipt or invoice, displaying the retailer's name, date of purchase, product name, and purchase price

6.4. The Offer is not transferable and cannot be exchanged for cash or any other monetary value or equivalent.

6.5. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Participant; or (b) subject to any written directions

from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.

- 6.6. Any costs associated with accessing the Promotion website is the Participant's responsibility and is dependent on the Internet service provider used.
- 6.7. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence); or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoters control); (b) any theft, unauthorised access or third party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in value to that stated in these Terms and Conditions; or (e) any tax liability incurred by a Participant.

## 7. CHANGE OF TERMS

These Terms and Conditions are final and binding. The Promoter reserves the right to amend or cancel the terms of this Promotion or to withdraw this Promotion at any time without reason and without any compensation or liability to Participants.
