2. Hazards Identification

2.1. Emergency Overview:

This toner does not meet the criteria for dangerous classification according to EU Directive 1999/45/EC. This toner is a Cyan powder that may cause eye irritation. Avoid contact with eyes or clothing. In

4. First Aid Measures

Routes Of Overexposure: Eye, skin, inhalation, and oral

Acute Health Hazards:

• Overexposure of eye surface to toner may be mildly irritating

- Overexposure of skin to toner contact may cause irritation and in some people swelling and redness
- Intentional inhalation overexposure to toner may result in respiratory tract irritation
- Intentional or accidental oral ingestion may cause an upset stomach

Chronic Health Hazards: Prolonged inhalation of excessive dust may cause lung damage. It is attributed to

"lung overloading", a generic response to excessive amounts of any dust retained in the lungs for a prolonged interval. Use of this product, as intended, does not result in

inhalation of excessive dust.

In a study in rats by chronic inhalation exposure to a typical toner, a mild to moderate

degree of lung fibrosis was observed in 92% of rats in the high concentration

 (16mg/m^3) exposure group, and a minimal to mid degree of fibrosis was noted in 22% of the animals in the middle (4mg/m^3) exposure group. But no pulmonary change was reported in the lowest (1mg/m^3) exposure group, the most relevant level to

potential human exposures.
